Koretskaya M. The ambivalence of the sacral and the ambivalence of power: from the anthropological conception to the philosophical problem

The purpose of this article is a preliminary substantiation of the concept of ambivalence of power within the context of the ambivalence of the sacred. Power in modern philosophy has been one of the most preferred topics and at the same time the concept of "power" has equivocal meaning: from the Nietzsche's philosophy, power is understood both as a creative power, and as a repressive machine of domination. The hypothesis is that the philosophical concept of power is ambiguous because the power as a social phenomenon has an ambivalent character. The traditional way of legitimizing power lies in its sacralization. However, because of the fact that the sacral is ambivalent (can be related to both the blessing and the curse), the same characteristics of ambivalence are initially inherent in power.

In my paper, I focus on the question of transcendence which is described as "the basic structure of subjectivity". In order to clarify Heidegger's main point regarding transcendence, I introduce the term "interest" and explain how transcendence as the finite human freedom can be the origin of "grounding".
